### SAND DUNE INVASION: AN UPDATE

Herewith a brief update on progress to date with submission and approval of the Betty's Bay Beachfront Management Plan.

The Betty's Bay Beachfront Management Plan, paid for by donors from the Betty's Bay Dune Interest Group and the Betty's Bay Ratepayers Association, has been submitted to the Department of Environmental Affairs and Development Planning (DEADP) by the Overstrand Municipality (OSM) late last year. It was hoped that the plan would be approved by DEADP before the Christmas break, as they have been consulted during the generation of the plan.

Sadly this did not happen and DEADP has responded only by mid-February 2016 requesting changes to be made to the Plan. At a meeting held on 22 March and attended by the BB and PB Ratepayer Associations, the BB Dune Interest Group, OSM and Cape Nature it was explained that DEADP felt that some aspects of the Plan (construction of boardwalks) would have to trigger an Environmental Impact Assessment process and OSM had been requested to remove reference to boardwalks as this could always be added later after the required procedure had been followed.

DEADP also provided a template, previously used for maintenance of riverbanks, which they are comfortable with and which they would like to develop for use in other sand encroachment situations with BB and PB serving as a pilot project. The OSM has undertaken to make the changes to the Plan (at no further cost to the ratepayers), with emphasis on re-instating the parking area and the dune system to the conditions of ten years ago based on the "like for like" principle in the law, and to resubmit it to DEADP as Maintenance Management Plan. This first draft of the revised document is being circulated informally (also to DEADP) for comment before formal submission. It is hoped (no firm undertakings!) that the revised Plan would be approved by mid-April.

Unfortunately funding is now becoming even more problematic. The little money that the OSM has available for implementation has to be spend before their financial yearend or be lost and it seems unlikely that this the tender and contracting process will be possible in time. The funding by central Government for the Work for Coast job creation programme also seems to be in jeopardy due to promises made by Government to the #everythingmustfall movements and we are still waiting for confirmation on the actual funding available.

The OSM has approached the City of Cape Town to borrow one of their bulldozers to move sand during the winter months, but funding for the relocation and the fuel for the machine still needs to be secured. Funding from the central Government Municipal Infrastructure Fund is being investigated.

On the bright side is heartening to note that the OSM Department of Environmental Management and also Cape Nature is fully committed to, in partnership with the ratepayers, expedite this process.

### **BABOONS AND THE MUNICIPALITY**

From a query regarding baboon control that the BBRA recently received, we gleaned this short informative response from Desmond Lakey of the Overstand Municipality.

The Overstrand Municipality does not have any constitutional authority to undertake the identification, entrapment and translocation of baboons which are frequent food raiders. Nor have any such powers, functions or duties been assigned to the Municipality by an agreement in terms of section 156(4) of the Constitution. This is a functional area of concurrent national and provincial legislative competence, classified under "animal control."

Applied to our situation, it means that Cape Nature has been assigned with the abovementioned duties. It may in writing authorise such persons as it may deem necessary to hunt such wild animal or such number of such species determined by it. It may thus cause baboons which have been identified as frequent food raiders to be hunted by persons authorised by Cape Nature.





When making a request for the hunting of baboons which are frequent food raiders, the Municipality cannot request that it itself be authorised to hunt them, because the hunting of baboons is not one of the things which, at present, the Municipality is authorised to do in terms of the Constitution. However, if an assignment under section 156(4) of the Constitution gives to the Municipality an authority in relation to the control of baboons in the urban areas in the Municipality's area of jurisdiction, it will enable the Municipality to make, under section 156(2), an all-encompassing by-law on the subject, including baboon monitoring, the identification of frequent food raiders and the translocation (if feasible) or hunting of frequent food raiders. Having done so, the Municipality may then administer the by-law and lawfully incur expenditure in connection therewith.

#### A NOTE FROM YOUR EDITOR

The school operates from 7 a.m. to 4.30 p.m. every day, including during school holidays. It closes for 3 weeks over Christmas. The children are fed at school.

Most children come from very poor homes and their parents cannot afford to pay school fees. The allocation per child from the state is pitifully inadequate and not all children are catered for by the state.

# Feedback on Ecological Matters at Stony Point

### THE AFRICAN PENGUIN

The South African population of the African Penguin, 2015 census: 19000 breeding pairs or 38000 adult breeding penguins, of which Stony Point supports 13% of the national breeding stock of this endangered species.



### **AFRICAN PENGUIN ANNUAL MOULT**

- The annual moult season commences from October, with a peak occurrence in December. It then tapers off in the early months of the following year.
- Every penguin will moult every 12 months like clockwork. During the moult the birds have to remain ashore because feathers are shed and replaced. The moult phase is the most sensitive period in the annual cycle for the African penguin.
- Moulting penguins at Stony Point 'loaf' within the intertidal zone of the coastal fringe as this location is the coolest environment where natural and sustained metabolic processes can evolve with detriment to this annual fasting phase.
- Peak count: December 2015 was 1973 adult moulters and 416 juvenile moulters.

#### AFRICAN PENGUIN CHICK BOLSTERING PROJECT

This conservational intervention currently aligns with the actions and tasking as required and as per Government Gazette #36996, 31 October 2013 – Department of Environmental Affairs pertaining to Objective 4.2.6 and Action 4.2.6.3 of the Biodiversity Management Plan for the African Penguin.

- Owing to the onset of adult moult at Stony Point, which commences in October, nest sites become abandoned.
- Chicks remaining on the nest would eventually starve to death in the absence of parents, owing to the onset of the annual moult season. These chicks are identified as 'wanderers' in poor condition.



- Evening observations are conducted where abandoned chicks are identified;
   where possible, without disturbing normal commute activities of adults returning to active nests, these chicks are removed.
- Those removed during the moult season are stabilized and then transported to SANCCOB for rehabilitation rearing and are later released back into the wild as 'blue' fledglings.
- 286 abandoned chicks where removed in November, with 39 deaths at SANCCOB.
   228 were released, 197 at Stony Point, and 18 remain at SANCCOB.

# SUMMARY OF 2015 AFRICAN PENGUIN COLONY OCCURRENCES [JANUARY TO DECEMBER]

- Abandoned nests with egg content 1287 [February to March]
- Predated eggs 346. Predated chicks 143. Predated adults 225 [93% within the residential]
- Natural death chicks 232. Natural adult deaths 9.
- Injured 80 [38% of associated admissions]
- Oiled 14
- Sickly 41 [including arrested moulters]

### CAPE CORMORANT

This species is currently listed as an endangered seabird, owing to population decline.

- Summer breeder commencing in September and brood attempts cease in February.
- Predominantly brood in the southern aspect of the Stony Point colony.



2015/2016 seasonal census at Stony Point concludes a total of 901 active nests.

#### **BANK CORMORANT**

This species is currently listed as an endangered seabird, owing to population decline. There is a breeding population of 220 pairs in South Africa. [Namibia supports the largest population of this species.]



- Summer to Autumn breeders
- Stony Point is the home to the largest Bank Cormorant breeding population in South Africa, consisting of a mere 62 breeding pairs.
- Clutch size: 1 3 eggs per attempt
- Nest sites is vulnerable to high winds and high seas, owing to the location of the nest site colony – atop the rocks of Beacon Bay.
- Currently there are 22 active nest sites with egg content.

#### **CROWNED CORMORANT**

With fewer than 2000 breeding pairs in the home range, this is one of the rarest birds in the world.

- Stony Point supports a breeding population of 26 breeding pairs [alongside the Bank Cormorant] in the May peak and then 39 breeding pairs in the October breeding period [alongside the Cape Cormorant].
- Vulnerable to disturbance and extreme weather.



#### **BLACK OYSTERCATCHER**

This is a vulnerable shorebird breeding species that predominantly breeds in and along the coastal fringe, just above high tide levels – in sandy shore lines – and it forages in the rocky intertidal zone.

- Oystercatchers breed predominantly during the months of November to March.
- Nest sites are vulnerable to human traffic above the high water marks of sandy shore-



lines. They are also vulnerable to free-roaming dogs that are not under the direct control of recreational beach users.

- Over recent years the nest sites have been monitored and areas of high nest site
  densities have been mapped for annual monitoring purposes.
- Within the coastal boundaries of the Betty's Bay Marine Protected Area, 12 active nests were monitored throughout the 2015/2016 breeding season to determine the success of attempts.
- Seven of the 12 monitored nests were successful and a total of 21 chicks fledged in this breeding season, marking this as the best year for the oystercatchers breeding within our MPA boundaries.

# BETTY'S BAY - WHERE WHALES PLAY AND WILD FLOWERS BLOOM

Betty's Bay is a beautiful small holiday town situated on the Overberg coast of South Africa's Western Cape province. Just an hour's drive from Cape Town it sits beneath the rugged Kogelberg Mountains on the scenic R44 ocean drive between Pringle Bay and Kleinmond. Tourism plays a large role in the town's economy due to the its popularity with holiday makers from across the Western Cape and Cape Town in particular. This village is the longest in South Africa at over 13 km.

Betty's Bay is situated in an area known as the "Heart of the Cape Fynbos Floral Kingdom". The area is considered to be of such ecological importance that in November 1998 it became the first UNESCO-declared Biosphere Reserve in Southern Africa. It's historical background is rich with wild and romantic stories of shipwrecks, pirates, runaway slaves, cattle-thieves and strandlopers. In fact the area became the stronghold of outlaws and the remnants of Khoisan tribes for almost two centuries. Although hunting was possible they lived mainly from the sea, collecting shellfish and trapping fish.






However, man's roots in this area go back even further.

William Paterson, who travelled the region between Somerset West and Bot River in 1771, gave accounts of wild life such as zebra, bontebok, buffalo, eland and even hyena. However, man's roots in this area go back even further. At De Kelders, the only fresh water caves on the coast of Africa, archaeological digs uncovered artefacts of a civilisation dating back 80 000 years ago. At Hangklip stone hand-axes from the Neanderthal era about 20 000 years ago have been unearthed.



Khoisan strandlopers used to leave their fish traps and middens along the coastline. Close to Betty's Bay stone-packed fish-traps are still visible at low tide. Shell middens are found all along the coast. During Colonial times Betty's Bay was a favourite place for runaway slaves.

According to a brochure of the Tourism Board a whaling station was established in 1913, at Stony Point on land belonging to a Mr. Walsh who leased 60 acres to Mr. Frank Cook who employed a small group of Norwegians. They built the station and managed the factories. In 1917 Irvin & Johnson Ltd. took over the whaling station, which they operated till 1930 when the price of whale oil had fallen to such an extent that the whaling station finally closed.



Remains of the whaling station can still be seen at Stony Point. Of the large constructions like the boiler shed, the blubber house (the old building that served as a whale-oil warehouse.) the oil storage tanks, the employees' quarters, meat house, guano factory and pump house, not much is to be seen.

The land was later sold to a consortium consisting of Arthur Youldon, Jack Clarence and Harold Porter, who called this the Hangklip Beach Estate. Three towns were established namely, Rooiels, Pringle Bay and Betty's Bay.

Betty's Bay is said to have been named after the daughter of Arthur Youldon.

During the Second World War the Hangklip Hotel was the barracks for personnel manning the (still visible) radar station high on the slopes of Hangklip Mountain, watching out for German U-boats. Another radar station was situated at what is now Mooihawens.

Italian prisoners of war did construction and built the road from Gordon's Bay, which is now known as Clarence Drive. Prior to this the area was accessed via Sir Lowry's Pass and Kleinmond with a pontoon crossing the Palmiet River. The difficulty experienced in travelling to Betty's Bay prior to World War II kept it off the map for most people in the early days. The fact that electricity was introduced to Betty's Bay only in the 1990s meant that the village had limited appeal. This has stemmed the development and allowed Betty's Bay to remain pleasantly underdeveloped.
