#### Discussion and decision

**Chlorine:** There seems to be a shortage and could affect us, ie. water chlorination plants. It was decided that Rob would investigate and report on the situation.

**Date/time for this meeting:** Could we have it later than 16:30. **It was decided that we would meet every 2<sup>nd</sup> last Wednesday of the month at 17:00** at Crassula Hall unless otherwise stipulated.

**Portfolios:** Those with two caps: It was **decided** that **each membe**r would **carry one portfolio** and if required a temporary member would be brought into the fold to represent a portfolio.

Committee/community meetings: It was decide that there would be committee meetings in January, February, April, June, August, October, November (function) and December (AGM). Community meetings would take place March, May, July, Sep of each year with short committee meet after each of these, if necessary.

Ward Committee Reps: It was decided that the Chairperson Wayne Jackson would represent the BBRA with Liz Buncker as the alternative rep.

Chair coms with Committee: Gen info/very short decisions or opinion/emergency items: It was decided that the existing WhatsApp group for committee members would be updated and used as communications between members.

Communication protocols with Municipality: It was decided that principals(portfolio holders) may communicate Directly to section heads within the municipality and CC the Municipal Manager as well as BCC the committee.

Extra members: Not committee members but members with portfolios in terms of organisational rep or volunteers for an area of importance or interest. It was agreed that the operations officer from BBNW would be opted into the committee for the neighbourhood watch and Mark Fletcher would manage the Crassula Hall and the 3 notice boards.

**Admin:** Hand over re secretary and scribe: It was **decided** that **Adrian and Karon** would hand over all their tasks to the **new secretary, Dorrienne Maes**.

It was *unclear* about the *IT/Communications portfolio* and the portfolio that Wendy Lucas was overseeing. It was decided that nothing could be left out or ignored and Wendy was asked to relook at how the committee should decide on a way forward.

Richard gave a short talk on the way in which the new measurement systems would be implemented and the reason for the system.
